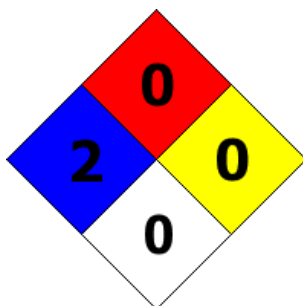

SECTION 5: Firefighting measures

Extinguishing media

Suitable extinguishing agents:

Protective equipment:
